Right to participate

The Competitions are open to every self-employed master butcher from home and abroad, as well as their employees with specification of the employer. The participants from Germany must be a member of the competent professional butcher's organisation.

General competition conditions/data protection

The submitted samples must comply with the regulations pertaining to foodstuffs, especially those shown in the "Guidelines for Meat and Meat Products". Submitted samples will not be returned by the organiser. The costs of samples, which were registered but not submitted, will not be reimbursed. Insufficiently stamped samples, samples submitted after the deadline and/or non-edible products will be excluded from judging; the paid participation fee will not be reimbursed. Approved products

Approved are all sausage-like products in accordance with Guidelines 2.224.4, e.g. pickled pork knuckle pâtés, tongue pâtés, tongue roulades, fillet pâtés, imitated wild boar pâté, but also minced pâté products such as mosaic pâtés, chequered pâtés, firm liver pâté in accordance with Guidelines 2.224.4.

The pâtés must have a décor edge with meat, bacon or sausage meat and be hand-made.

No separated meat may be used!

Sample size

- Either complete roulades or pâtés – minimum weight 1 kg.
- With large roulades or pâtés – minimum weight 1.2 kg.

Cut samples may not take part in the Competition!

Number of samples

Every company may submit any number of samples for judging. However, only 1 sample may be registered each time under a sales name.

Judging criteria and their maximum number of points

Judging will be based on the DFV testing conditions (50-point scale):

1. External condition, condition of the container
2. Appearance, colour, composition
3. Consistency
4. Smell and taste

Assessment table for the individual type of sausage:

Gold	50 points
Silver	45 – 49 points
Bronze	40 – 44 points

Information on the collection of data according to Articles 13 and 14 of the GDPR
